# Summary of key findings for parents

## This provision is outstanding

- The quality of teaching is excellent. All staff are extremely knowledgeable about children's level of development. Assessment of children's progress is precise and outstanding systems are in place to collect, analyse and check data. This information provides a clear overview of the rapid progress children are making. Improvement since the previous inspection is impressive.
- The leadership and management structure is inspirational. The manager and senior staff are outstanding role models and give exceptional guidance to the highly impressive staff team.
- Experienced and highly enthusiastic staff provide an exceptional range of interesting and challenging activities that motivate and engage children, as well as promoting high levels of confidence and independence. Staff question children skilfully and encourage them to think critically for themselves and explore ideas. This helps to develop their knowledge and understanding extremely well.
- Partnerships with parents are excellent. Extensive systems are in place to share information with parents and they are completely involved in every stage of their children's learning. Staff give fantastic encouragement, support and guidance to parents to enable them to continue their children's learning at home. Parents value highly the compassionate care that they and their children receive.

# What the setting needs to do to improve further

## To further improve the quality of the early years provision the provider should:

extend and enhance further the excellent opportunities for outdoor learning.

## **Inspection activities**

- The inspector observed the quality of teaching during activities indoors and outdoors and assessed the impact this has on children's learning.
- The inspector completed a joint observation with the manager.
- The inspector held discussions with the management team. She checked the records of suitability checks and qualifications of staff working in the nursery and discussed the provider's self-evaluation and improvement plan.
- The inspector sampled documentation, including children's assessment records, planning documentation and children's learning folders.
- The inspector spoke to staff, children and parents during the inspection and took account of their views.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The manager and staff have an excellent understanding of safeguarding procedures and child protection issues. The manager is extremely skilled at evaluating the quality of the provision, incorporating the views of parents, staff and children. This helps to significantly enhance experiences for children and improve practice. For example, outdoor provision has been successfully redeveloped to create a safe and enriched high-quality learning environment. The manager plans to improve provision further by making the most of all three areas to ensure children gain the maximum learning experience. The manager uses rigorous recruitment and induction procedures, and also meetings, such as appraisals, to monitor staff's ongoing suitability and identify their training needs.

## Quality of teaching, learning and assessment is outstanding

Staff are extremely responsive to the needs and interests of the children. They extend children's learning expertly, encouraging them to think about and solve problems for themselves. For example, children focus intently as they predict which materials will keep an egg safe when they drop it from a certain height and give reasons why. Children's communication and language are promoted exceptionally well. Staff provide an array of additional words, building on children's emerging vocabulary. They ask appropriate questions and introduce mathematical language throughout the day. For example, children learn how to use a number line to add and subtract.

#### Personal development, behaviour and welfare are outstanding

Staff are remarkably caring and form extremely strong bonds with children, who are exceedingly happy and secure. They support the children's emotional well-being superbly well. Children thrive in this warm, friendly, welcoming environment. They have countless opportunities to be independent. For example, they take great pride in carrying out special jobs, such as appointing monitors to help throughout the day. Children's physical care and well-being are exemplary. Children take part in a wealth of activities, such as physical exercise and drama classes. Children's behaviour is exemplary. They respect one another, the staff and their environment exceptionally well.

#### **Outcomes for children are outstanding**

Children are making excellent progress in all areas of learning in relation to their starting points. They are extremely confident in using their counting skills to solve numeracy problems. Children develop excellent literacy skills. For example, older children confidently read words and write their name independently. The children demonstrate strong perseverance and attention to tasks, and become highly inquisitive learners. They are extremely well prepared for the next stage in their learning, including school.

Clowns Nursery Care registered in 1994. It operates in Golders Green, in the London Borough of Barnet. The nursery is open for 50 weeks a year, from 8am to 6pm, Monday to Friday. The provider employs 52 members of staff, 45 of whom hold relevant childcare qualifications at level 2 or above. Two members of staff hold qualified teacher status.
